Financial Records : Letter from the Employer: Letter from your Employer, stating the Salary / Income, Job Description and number of years of Employment or Bank Letter: Letter from your Bank confirming Financial Stability and capability for travel to the Country.

- ❖ A2Z Services is providing this facility for its customer. A2Z Services do hereby declare that they have no role whatsoever in the assessment of a visa application, which is the sole prerogative of the Government /Immigration Department. Therefore, neither A2Z Services nor Airlines will in any manner be liable or responsible for any delay in the processing or rejection of any visa applications.
- ❖ This facility is open for Customers visiting travelling on the Airlines and fulfilling the eligibility conditions announced from time to time by the Authorities.
- ❖ Issuance and approval of a visa is solely regulated by Government and governed by their rules and regulations that may be amended from time to time. The application subject to Customers fulfilling the eligibility conditions.
- ❖ **Visa fees are non-refundable under any circumstances whatsoever.**
- ❖ **Customers desirous for a visa should be holding a valid ticket travelling onwards Airlines and booked. A2Z Services will not be responsible for and will not be liable for Customers not been able to travel due to denied boarding offloading, cancellation of flight, delays or and any other cause or circumstances beyond A2Z Services control. - ❖ The decision to grant or refuse a visa is the sole prerogative of the Immigration Authorities and it is final. In case of rejection of visa application, the applicant will be informed of such, no correspondence will be entertained, no visa fees will be refunded and no reasons will be required to be given. It is understood that whenever the processing of the visa application is prevented, delayed, restricted or interfered with for any reasons whatsoever by THE Immigration Authorities to process Customers visa application, then Airlines or A2Z Services shall not be liable to any Customers for any loss or damage which may be suffered as result of such causes and Airlines and A2Z Services shall be discharged of all its obligations hereunder.
- ❖ Issuance of a visa or approval on the visa application does not in any way guarantee the Customers the right to enter THE. The entry is at the sole discretion of the Immigration officer at the Airport. In case of denial of visa or entry into THE by the Government, Airlines or A2Z Services shall in no way be liable to Customers in any manner whatsoever.

- ❖ Customers are advised to carefully go through the “Note” printed on your visa for “validity of permit” and “duration of stay”.
- ❖ Only machine readable Passports will be accepted. Hand written Passport will not be accepted.
